**Better Families is aimed at preventing neglect and abuse before foster care is necessary. Our unique model enables parents who have fallen on hard times to voluntarily place their children with a loving host family for up to a year. Although, the average stay is only 41 days, and 90% of families are reunited in 90 days or less. As unpaid volunteers, host families focus on caring for the children, while a network of Better Together volunteers and partners help the parents get back on their feet. The Better Families program has served more than 2,750 children with a 98% success rate of keeping them out of government foster care. The Better Jobs program has partnered with over 100 churches nationwide to provide more than 228,000 disadvantaged people with employment opportunities.**

**Better Jobs is a program that equips local churches to run a community or second chance job fair - offered either in person or virtually - right where it's needed most.
